PRESS RELEASE: REVENUE UP BY RS. 11.05 %, PAT UP 74.54%, & EPS UP BY 73.86% IN FY19

New Delhi, May 28, 2019: CMI Limited, at the meeting of its board of directors held on 28.05.2019 approved the audited financial results for the quarter and year ended March 31, 2019.

Highlights: Consolidated:

- Revenues up by 11.05% to Rs.637.29 Crores in FY19 as compared to Rs. 573.90 Crores in FY18. It has increased by 16.40% to Rs 185.92 Crores in Q4 of FY19 as compared to Rs. 159.72 Crores in corresponding quarter of FY18.
- PAT up by 73.86% to Rs.45.08 Crores in FY19 as compared to Rs. 25.83 Crores in FY18. It has increased by 280.66% to Rs 25.96 Crores in Q4 of FY19 as compared to Rs 6.83 Crores in corresponding quarter of FY18.
- EPS up by 73.86% to Rs.29.91 in FY19 as compared to Rs. 17.20 in FY18.
